▶ **TERMS AND CONDITIONS OF THE “50 USD NO DEPOSIT BONUS” PROMOTION**

1. The “50 USD NO DEPOSIT BONUS” promotion (hereinafter - Promotion) is applicable for new Clients who have completed a Profile registration form a dedicated promotional URL during the promotion time, and who fully verified profile within 72h following the registration.
2. By registering Profile and opening a trading account during the term of the “Promotion”, the Client acknowledges that he has read and agreed to be bound by these terms and conditions as well as by FxGrow Trading Terms and Conditions.
3. The “Promotion” and the 50 USD trading credit is limited to one account per Client.
4. The expiry date of the trading credit is 30 days, counted from the date that the credit was credited.
5. Profits from trading on the credit under may be withdrawn anytime, provided that the trading volume of 1 standard lot with at least 5 rounds turn trades were completed.
6. The minimum amount that can be withdrawn from any account that participates in this “Promotion” cannot be less than 100 USD or its equivalent in other currencies.
7. In order to be able to withdraw funds form the account participating in the “Promotion” all orders (including pending orders) must be closed.
8. Bonuses cannot be separately transferred between, or from Eligible Clients’ real trading Accounts with FxGrow.
9. Once granted, the no deposit bonus cannot be transferred to any other FxGrow trading account.
10. Please note that it might take up to 48 hours before the no deposit bonus is added to the account of eligible Client.
